Dear Families,

It is registration time for the 2016-2017 academic year. We hope you will be part of another great year at Saint Jerome School! In order to know which grades will have seats available for new families and to set tuition rates, we ask that you to complete the form on the reverse side of this page and return it with your cash or check deposit by March 1, 2016, or you may elect to deduct your deposit from your current FACTS account during May 2016.

The strength of our school depends on prompt payment of tuition. The FACTS program makes this simple and convenient. **All payments**, except for credit card options, must be made through the FACTS Plan by setting up an account prior to June 30. This includes tuition paid in full. If you pay in full, your FACTS fee will be credited to your account.

A \$200.00 non-refundable deposit is required for each child upon registration. The full deposit amount is applied to the tuition balance if received before March 1, 2016, or deducted from your designated bank account by FACTS in May 2016. Half of the deposit amount will be applied to the tuition balance if the deposit is received after March 1, 2016.

A limited amount of financial aid is available. In order to be eligible for funds through the Catholic Schools Foundation or local assistance, a family must be enrolled in the FACTS Plan. Should I withdraw my child after the first day of school and through November 30th, I will be responsible for 50% of the full tuition. Should I withdraw my child after November 30th, I am obligated to pay the full year's tuition.

I understand that if my tuition payments fall in arrears, my child will not be permitted to participate in extracurricular activities and/or school attendance until the account is brought up to date. (If you have difficulty paying tuition, please contact the Principal or Collaborative Director of Finance and Operations immediately.)
