The strength of our school depends on prompt payment of tuition. The FACTS program makes this simple and convenient. **All payments, except for credit card options, must be made through the FACTS Plan by setting up an account prior to June 30.** This includes tuition paid in full. There are no FACTS fees for payments made in full through FACTS.

A cash or check deposit of \$200 for each student will be due at registration. For returning students, the full deposit amount is applied to the tuition balance if, on March 1, the registration form and deposit are received or FACTS has been authorized to withdraw the deposit from the designated bank account in May. If a returning student’s registration is received after March 1, half of the deposit amount will be applied to the tuition balance. For new students, the full deposit amount is applied to the tuition balance.

A limited amount of financial aid is available. In order to be eligible for funds through the Catholic Schools Foundation or local assistance, a family must be enrolled in the FACTS Plan. Contract: I understand that by enrolling my child, I am reserving his/her seat for the year and I am obligated to pay the full year’s tuition. Should I withdraw my child after the first day of school and through November 30, I will be responsible for 50% of the full tuition. Should I withdraw my child after November 30, I am obligated to pay the full year’s tuition.

+Tuition includes an obligation of service requirement. Each family is required to provide 20 hours of service specific to the academic year and to purchase one \$10,000 drawing ticket. Service hours will be tracked by the school and financial restitution will be required for any unmet service obligation. If you choose to opt out of the obligation of service requirement, \$450 will be added to your tuition balance and you will be credited with the purchase of one \$10,000 drawing ticket.

If I am enrolling my child after the academic year has begun, I agree to pay tuition in the amount of \$_____.

I understand that if my tuition payments fall in arrears, my child will not be permitted to participate in extracurricular activities and/or school attendance until the account is brought up to date.
